Footnotes

SON OF A BEAR prompted the pace while racing three wide around the first turn, launched an outside bid down the backstretch, took command near the quarter-pole, inched away while racing three-wide around the far turn, slowly widened under a steady drive through the lane. I GOT A ANSWER pressed the pace in the two path, moved with winner down the backstretch, continued to race between rivals around the far turn, finished willingly along the inside to hold the place. NEW VISION exchanged bumps with ROBB TRADE just after the start, bumped TRIPLE OPTION after the start, stalked the leaders from the rail, moved up inside around the far turn then finished evenly in the lane. RUTLEDGE LION angled toward the rail entering the first turn, stalked the leaders while racing two to three wide, lacked the needed closing bid. TRIPLE OPTION was soundly bumped after the start, lacked speed inside, moved up around the far turn, rallied belatedly through the stretch. DI COLAS EX was caught four wide into the first turn, moved up outside down the backstretch, lost ground four wide around the far turn, lacked a closing bid. SHOWMETHETRICK set a pressured pace along the rail, gave way around the far turn. LOUD RAVENS was never a factor. ROBB TRADD exchanged bumps with NEW VISION just after the start, was never a threat. KING'S GLORY saved ground to no avail.
