SAY FRENCH FRY pressed the pace three wide, dropped to the rail on the turn, lacked a late response. COCOA CREAM advanced four and five wide, lacked the needed rally. SWEET AND WILD never threatened six wide. HEATED CHASE passed tiring rivals. CYBERCHASE forced the pace on the rail, lacked a closing bid. MOM'S GRANDEUR only had brief foot.
