PEACE TOWN set the pace on the rail, drew off around the turn, held clear through the stretch while under a drive. MR. PRIME TIME closest to the winner throughout, could not gain appreciably on the winner while clearly second best. SHAMSS advanced three and four wide, lacked a late response. DISCO INDY prompted the issue from the inside, lacked a closing bid. THINKING OUT LOUD within striking distance three wide, failed to respond when asked in the lane. JENKIN JONES well placed on the rail, had no rally. ON ONE NOD made little impact, three wide. AQUINAS stalked the leaders three wide, lacked the needed rally.
