MR. MARKET stalked the early pace from between foes, crept closer entering the second turn, made a bid mid turn, gained command and was clear late while kept to task. RUTLEDGE STAR well placed from the inside, made a bid entering the second turn but could not reach the winner. PARKER'SGOLDENCAT up close from the outside, advanced entering the second turn, responded but could only gain the show. HAWKEYE VIEW duelled from the inside for the early lead, gained a clear margin up the backstretch, remained a forward factor entering the drive but shortened stride late. ADALRICO could only improve position. DIXIE CAUSEWAY could only pass tired ones. LONG SHADOW was no factor. DIABLO'S HOLIDAY duelled from the outside and gave way. BREWSTER COUNTY was finished after going a half. LEON'S WAY showed little.
