**Footnotes**

ESCROW KID dueled outside of MALIBU KID for a half, drew clear leaving the quarter pole and held sway under a drive. MALIBU KID dueled inside of the winner for a half, steadied when in a bit tight as the winner angled in near the quarter pole, angled out nearing the lane and finished willingly to narrow the gap in the lane. WINK AT THE GIRLS settled off the pace in the three path, bid outside nearing the five-sixteenths pole, could not match strides with the top two while racing in the two path around the far turn, lost third in midstretch but kept trying and re-claimed the show in the final strides. WINGED HERO was unhurried while saving ground early, raced three wide around the far turn, moved into third in midstretch then flattened out and lost that spot in the final strides. LOVE TO THE MAX settled off the duel in the two path, bid three wide between rivals near the five-sixteenths pole then faltered around the far turn. OFFICER ROCKET (GB) was off a bit slow and trailed off the rail. The rider of MALIBU KID claimed foul against the winner, alleging interference near the quarter pole but the Stewards found no reason for disqualification.
