**Footnotes**

KARDOKAN settled back from the early pace inside, bid leaving the seven sixteenths pole, angled outward rounding the final turn, entered the stretch five wide, closed to the lead in late yards and was edging away from the runner-up under the wire. FINE CASHMERE moved clear for inside position to rate the pace inside, was pressured from the three eighths pole, dug in with the advantage under hardy handling but yielded in late yards. CHEROKEE'S GIRL stalked the pace two deep, challenged the pacesetter toward the three eighths pole, rounded the final turn at the rail and ran evenly to late stretch before leveling off. MY GIRL KATELYN stalked the pace three wide, bid leaving the three eighths pole, held aim through the final turn, was turned back at the top of the stretch and leveled off nearing the wire. CREDIT RISK, on the heels of rivals the opening turn, settled off the pace about the three path, was pressured from the half mile pole, rounded the final turn four wide then leveled off in the stretch. PHRYGIA and MINERS BLUES raced well back and never factored. FLO JO'S AFFAIR, off the early pace about the three path, showed no response after three eighths.
