**Footnotes**

WATCH TOWER broke sharp from the inside to gain a clear early margin, widen the advantage entering the turn, remained well clear at the eighth pole and was clear late under steady urging. LIKE PARKER DREAMT chased the early pace from the outside, dropped inside entering the stretch and finished strong along the rail. CARINA BAY well placed from the inside, made a bid entering the stretch but could not keep pace. VIRGINIA HERO stalked the early pace from the inside, altered outside for the drive, responded but faltered late. FAST COUNTY forced the pace from the inside and tired. CHLOE'S KO PRIDE could only pass tired ones. BEAR GLADIATOR went evenly. DELISSIMO was no factor. THE SHINNING STONE came five wide into the turn and was outrun.
