Footnotes

CANDY HEART accelerated to the front for inside position, rated the pace through the backstretch, was pressured toward the quarter pole, driven into the lane and dug in under steady encouragement to last. PREMIER'S WHINNY settled off the pace inside, bid leaving the three eighths pole, eased out into the stretch and just missed in a strong finish. GUSKA'S GOLD stalked the pace off the rail, gave chase leaving the three eighths pole, lost ground leaving the final turn but dug in from there to regain and hold show. SOUND AFFAIR settled close to the early pace about the four path, gave chase leaving the half mile pole, leveled off in the stretch and was outfinished for show. JAZZ SEEKER saved ground well back, made a mild rail bid leaving the five sixteenths pole and had little left in the stretch. BETTER STEP ASIDE, off the pace outside, bid leaving the half mile pole and improved four wide to the middle of the final turn before weakening. OYKEL BRIDGE lunged at the break and was outrun. MINGUNS PROSPECT raced well back toward mid track. THEWAYOFTHE SAMURAI kept close to the early pace outside, gave chase leaving the first turn then faded three wide on the final turn. SPEEDY TUXEDO was no factor racing well back.
