**Footnotes**

INNER POWER settled off the pace along the rail, drew closer down the backstretch, gained along the rail into the far turn, tipped three wide near the three-sixteenths pole, steadily gained through upper stretch, took command leaving the sixteenth pole and withstood a late charge from the runner-up. COASTAL DRIVE was unhurried inside, gained three wide around the far turn, swung six wide nearing the lane and rallied outside. VINDICAT stalked the pace two wide, took the lead nearing the far turn, cleared off leaving the quarter pole and weakened in the drive. CANAVERAL DANCER chased the pace three wide, made a bid near the eighth pole, drifted in midstretch and flattened out. MOOKIE'S BROTHER failed to menace while racing two and three wide. LEVITE lacked speed inside, raced six wide around the far turn and passed tiring rivals. RICH DISCOVERY never factored while racing three wide. TYLER'S JEWEL was outrun while racing two wide early and five wide around the far turn. TAXICAB set the pace along the rail and faltered around the far turn. DANTASTIC trailed in the three path.
