FIRECARD set the early pace on the inside, drew off on the far turn, then was kept to pressure to prove much the best. LETS JUST DO IT was allowed to settle early, then was up to be clearly second best. PIMENTO had no rally while getting up for the show on the inside. QUOIT QUICK stalked the early pace three wide and weakened. COZY CON was well placed early on the inside and weakened. JENNASILPRINCESS failed to menace. SHESANOTHERGRUMP failed to respond. JUDGE'S APPEAL chased the early pace four wide and weakened. HEGIRA was not a threat while wide. TALKING POINT chased the early pace five wide and stopped.
