Footnotes

AUTUMN AFFAIR prompted the issue just off the rail, angled out three wide for the drive and under a strong drive was up in the final strides. MY GIRL JULES three wide down the backstretch, rallied five wide on the turn, closed with a rush. DI COLAS GIRL set the pace on the rail, led until the final strides. AMPLE OPPORTUNITY advanced three and four wide, finished strongly. COUNT YOUR PENNIES stumbled just after the start, was four wide along the backstretch, dropped to the rail on the turn, finished well. PRINTSCESS POACH with the leaders three and four wide, finished willingly. TURNING LYPH off the pace along the rail, bid three wide around the turn and closed strongly. GET GLUED ON pressed the issue three wide, stopped after a half. TUXEDO ANNIE flashed brief foot, five wide.
