Footnotes

PROOF'S REPAR lacked speed, circled both turns, closed and drove clear. DEVILISH BEAUTY accelerated to the early lead, set the pace along the rail and tired. ONE COOL DANCER, two wide, chased the pace and failed to sustain her bid. STAR KICKER saved ground, eased out two wide entering the stretch and lacked the necessary late response. WAY POINT lacked speed, entered the stretch in the three path and tired foes. KAIN'S CITY, pinched back leaving the starting gate, raced in the six path entering the stretch and passed faders. GREAT ASTON, two wide the first turn, chased the pace, was between horses turning for home and weakened. WHY RANSOM ME, three wide the first turn, raced four wide the far turn and was not a factor. I'M ALL IRISH, angled to the inner rail leaving the far turn, gave way in upper stretch. LADS STARLIT saved ground and was outrun.
