**Footnotes**

ALL ACCOUNTED FOR saved ground in a stalking position, eased out entering the final turn, closed steadily and was up in time. BLACKBERRY WINTER set a pressured pace along the rail and gave way grudgingly. BETTER SHOP AROUND saved ground, was slightly steadied in close quarters leaving the second turn, eased off the rail near the sixteenth pole and had a mild, late rally. LOOK OF HOPE prompted the pace two wide and weakened late. CLEVER REMARK lacked speed, was not a factor and passed tired rivals. CHIEF EXECUTIONER , three wide the second and third turns, weakened. DUENDE was outrun. ACT OF DOMINANCE , three wide the first turn, faltered entering the final turn.
