**Footnotes**

LOOKINATDBRITESIDE set the pace in firm control near the rail, was pressured leaving the seven sixteenths pole, dueled with a short lead rounding the final turn, drove clear into the lane then held on under steady encouragement though shortened stride toward the wire. CUTTINO CORNERS broke in checking, moved toward the outside early, gave chase leaving the half mile pole, saved ground on the final turn and got up late yards for place. MOYCULLEN stalked the winner off the rail, gave chase leaving the half mile pole, challenged that one from the seven sixteenths, was turned back rounding the final turn and weakened in the stretch. FIRST FEAR dropped back through the first turn, closed to the heels of D Wag nearing the quarter pole, followed as that one was eased outward through the final turn, angled back toward the inside and finished well. MOUNTAINEER MANIAC, off the pace toward the outside, saved ground on the final turn. WIN THE GREEN rated close to the early pace about the three path, gave chase leaving the first turn then faded saving ground on the final turn. D WAG came away awkwardly, saved ground off the pace, eased outward on the final turn and had no rally. CRAFTY HOT DANCE was not a factor.
