ROY L. unhurried early while outside rivals, steadily advanced up the backstretch, reached a striking position entering the third turn, gained the advantage at the eighth pole and was clear late under steady urging. RUTLEDGE STAR dueled from the outside for the early lead, remained engaged up the backstretch, held a forward position entering the drive but could not match strides. LEXI'S KNOCKOUT outrun early, advanced outside entering the third turn, responded and was gaining late. WESTERN FRONTIER chased the early pace from the inside but had nothing left. C V'S DEVELEN up close from the outside, tired in the drive. SPANISH AFFAIR dueled from the inside and tired. LUCKY TEN was finished early.
