PREMIER'S WHINNY outrun in the early going, began a strong advance three wide midway on the second turn, bid midstretch, powered by to win going away. GRAND SCIP lacked early foot, began a steady advance along the inside before a half, enjoyed a good trip while continuing along the rail into the lane, gained the nod for the place while no match for the winner. CAFE KOMODO cleared to the inside soon after the start, set the pace, continued to show the way into the lane, offered little resistance to the winner the final sixteenth, allowed the runner up the rail during that period and was nipped for the place spot. OYKEL BRIDGE went evenly paced throughout in lacking a closing bid. BETTER STEP ASIDE four wide into the first turn when well off the pace, lacked a rally. CLARKE COUNTY devoid of early foot, picked off a few tiring rivals while never dangerous. SOUTHERN FOLLY forwardly placed in the early going, staged a steady retreat. ASYLUM was never a threat. FREUDS ANA STREAK forwardly placed in the early going, gave way before a half. UNSHATTERABLE slow to settle after the start, trailed throughout in a dull effort.
