Footnotes

DOC'S REDEMPTION stalked the leaders three wide, bid around the turn, gained the lead in late stretch and drove clear. BUTLER advanced four and five wide, closed with a rush through the lane. EZ MAC set the pace on the rail, led until late stretch. MAMAS ICECREAM MAN four wide down the backstretch, bid three wide on the turn while exchanging bumps, finished well. THREE BULLETS within striking distance three wide, exchanged bumps with TIJUANA RUN around the turn, lacked a closing bid. FAMOUS ACTOR never threatened inside. TIJUANA RUN prompted the issue just off the rail, exchanged bumps with THREE BULLETS on the turn, lacked the needed rally. CAT RIVER showed little, three wide. COURAGEOUS ROY was used up after a half inside. SHIVAREE pressed the pace from the rail, tired. The rider of THREE BULLTS claimed foul against MAMAS ICECREAM MAN alleging interference around the turn. The Stewards reviewed the video tape replays but allowed the order of finish to stand.
