GANGA, unhurried off the rail, bid toward the five sixteenths pole, gained ground steadily through the final turn, took the lead entering the stretch then lugged inward while widening under only moderate handling. OUR HAE rated off the pace inside, bid leaving the half mile pole, ran up on the heels of Royal Eavesdropper nearing the five sixteenths pole and dueled that one for place while no match for the winner. ROYAL EAVESDROPPER took a slim lead inside entering the first turn, rated to the quarter pole, was pressured from that point, caught into the lane and yielded place to the runner-up midstretch. HUNTER MILL, well back, made a mild bid off the rail leaving the quarter pole. MR. BALLISTIC chased the pace off the rail, had aim nearing the quarter pole but weakened from the head of the lane. SUZANNE'S FRIEND was not a factor. CALL TIME had a brief early lead, stalked the pace two deep from the five eighths pole but faded after a half mile. NINTH CIRCUIT raced toward the outside and was through early.
