Footnotes

BAILEY BLUEYES saved ground approaching the first turn, rated clear to the five sixteenths pole, came under pressure from that point, held a slim advantage while contesting the final turn, was brushed entering the stretch and exchanged repeated contact with Call Our Gal at various points in the stretch before edging away from that one. CALL OUR GIRL settled off the early pace about the four path, improved her position through the backstretch, pressured the winner from the five sixteenths pole, contested the final turn with a slight disadvantage, drifted outward leaving the turn, came in making light contact with Bailey Blueyes in the upper stretch and exchanged contact at various points through the lane before giving way in late yards. GIRL PRIZE, unhurried and well back toward the outside, bid from the three eighths pole, rounded the final turn in the five path and closed for show before flattening stride. LITTLE PRIZED, well back in the four path, made a mild bid toward the final turn and finished evenly. FAST AND FRIENDLY rated close to the early pace inside, picked up the chase from the seven sixteenths pole but leveled off rounding the final turn. AIKEN VACATION, off the pace inside, showed no response down the backstretch. DUDDIE PRINDERELLA, off the pace about the three path, was urged from the seven sixteenths pole and stayed within striking distance to the quarter pole before weakening. C. M. WINGS was outrun. The stewards reviewed a claim of foul against the winning rider, lodged by the rider of the runner-up, though found insufficient cause to make a change.
