Footnotes

CAT O' NINE TAILS stalked the pace four wide around the first turn, bid between rivals near the five-sixteenths pole, took the lead near the quarter pole, vide inside of THEFUN'SJUSTBEGUN while racing in the two path around the far turn, emerged at the top of the lane with a clear lead when that rival drifted out and widened under strong left-handed urging. THEFUN'SJUSTBEGUN tracked the pace inside around the first turn, swung five wide leaving that bend, bid in tandem with and outside of the winner near the five-sixteenths marker, vied three wide around the far turn, lost ground while drifting out nearing the lane, could not match strides with the winner in the stretch and was second best. AMPLE OPPORTUNITY stumbled at the start, raced at the back of the pack in the three path around the first turn, was four wide entering the far turn, angled toward the rail near the three-sixteenths pole and rallied between rivals to gain the show in deep stretch. PRINTSCESS POACH stalked the pace three wide between rivals, bid between foes to take the lead near the five-sixteenths marker, briefly vied inside of the top two, could not keep pace while racing along the rail around the far turn and lost the show in the final strides. MALIBU KITTEN went evenly while racing three and four wide. MY GIRL JULES failed to menace while racing four and five wide. PROOF'S REPAR steadied early, was unhurried while racing in the three path around the far turn, raced five wide around the far turn and never threatened. AUTUMN AFFAIR saved ground to no avail. DEVONSPAINTEDLADY lacked speed while racing two wide, raced five wide around the far turn and never factored. LIMITMENOT set the pace in the two path and faltered nearing the far turn.
