Footnotes

LEVA MAE dueled from the inside for the early lead, dueled up the backstretch, shook loose entering the second turn, opened a clear margin and was clear late while kept to task. CYNTHIA'S ANGLE stalked the early pace from the inside, advanced entering the second turn, responded but was no match for the winner. GHOSTLY GIN VISION dueled from the outside for the early lead, dueled up the backstretch but could not keep pace. SISTER JANE forced the early pace outside but had nothing left for the drive. RELUCTANT STEP chased the early pace from between foes but had nothing left. VIVICAT chased the early pace from the inside, drifted out entering the drive, bothering rivals and was no threat. After a Stewards' Review VIVICAT was disqualified for interference in the stretch. DEVONSPAINTEDLADY was no factor. SAINT ZITA unhurried early, was bothered entering the drive and no threat. J. J.'S DEVIL had little impact. ROBBERY OR TAXES was outrun.
