### Footnotes

DESSERT DIVA broke sharp from the inside to gain the early margin, held a clear advantage up the backstretch, widen the effort entering the drive then prevailed under steady urging. MAKAIRA stalked the early pace from the outside, advanced entering the second turn, responded when sat down for the drive but could only gain the place. GUNNITE GRACIE forced the early pace from the inside, held a forward position through the second turn but could not keep pace. LALACE far back early, advanced outside entering the second turn, responded and finished well but too late. SLAMMIN ANNIE pressed the early pace from between foes but had nothing left for the drive. CINCO CINCO DIEZ chased the early pace but had no late response. SI SENORITA was never a factor. TRIPPIN MUTAKDDIM was no threat. B A HUMMINGBIRD chased the early pace and tired. DREWS SUPER SLAT was finished early.
