DRIFTING WIND stalked the early pace from the inside, dueled through the turn, remained engaged through the drive and outfinished rivals late. LORENZO dueled from the outside early, battled through the turn, remained engaged through the drive but was outfinished. GOLDZAR well placed from the inside, inched closer entering the turn, altered outside and finished well. STORM OR TWO dueled from between foes early, battled through the turn but could not keep pace through the drive. PUTITONWAYNESTAB chased the early pace from the outside but could only go evenly through the drive. SALTY AND FAST was crowded early and could only improve position. ACE AND JIM was no factor. CHURCHONSUNDAY dueled from the inside early, took a bad step entering the turn and had nothing left. RISEN IN DEED was no threat. PART OF MY FAMILY showed little.
