FAST TIME STREAKER stalked the early going from the outside, steadily advanced up the backstretch, reached a striking position entering the second turn, gained command and held sway. MAUK SALT chased the early pace from the outside, steadily advanced entering the second turn, responded when sat down for the drive but could not reach the winner. RUSTON STAR up close early from the inside, tracked the pace up the backstretch, remained forward for the drive but was outfinished for the place. PARK DAT unhurried early, steadily advanced up the backstretch, responded and finished well too late. Z'S COURT pressed the early pace outside but could only improve position. PRIZED PAL could only pass tired ones. COUPEE broke sharp from the inside, gained a clear early margin, dueled up the backstretch then tired in the drive. DROOLIN JO JO was no factor. ESCRITO PRAIRIE was no threat. CHA BONA dueled from the outside but gave way in the drive.
