LEAP DAY MYSTERY vied for the early lead, came around the final turn three wide, drifted in entering the home stretch, drove clear and was all out for the win. After viewing replay, Stewards disqualified him and placed him fourth. SILVER MITTEN challenged for the early lead, checked around the final turn, getting in tight quarters and finished willingly. BATTLE BOOGIE void of early speed, made a late bid and got up for third. WIRE ME WINNINGS went to the front, checked around the final turn, getting in tight quarters and lacked a late finish. DODGING RAINDROPS lacked early speed, showed late interest, but was no factor. MY FLASHY FRIEND brushed at the start, raced within contention and weakened. STILL QUICK raced near the back and was no factor. CLASSIC GOLD brushed at the start, raced in the middle of the field and faded. HOPEITWORKSOUT brushed at the start, raced near the back and was never close. MISS HAWK brushed at the start, raced within striking distance and dropped back.
