H AN F'S SENSATION broke sharp from between foes, gained a clear early margin, dueled up the backstretch, remained engaged with ARCTIC TRIBE through the second turn, dropped back, altered out, responded and was just up the final strides. ARCTIC TRIBE dueled from the outside early, remained engaged through the second turn, shook loose at the eighth pole, held a clear margin deep stretch but was caught the final strides. MY KAY SARA chased the early pace from the inside, crept closer entering the second turn, held a forward position for the drive but could not keep pace. STELLA'S RULER stalked the early pace from the outside, advanced entering the second turn, responded and finished well. ALEX'S TOP CAT up close early from the inside, drifted out slightly entering the first turn, dropped inside at the five sixteenths poled bothering PORTLY, chased the pace and finished belatedly. After a Stewards' Inquiry ALEX'S TOP CAT was disqualified for interference up the backstretch. GRAND ACCOUNT went evenly. PORTLY was steadied at the five sixteenths when ALEX'S TOP CAT drifted in, hit the rail then went evenly. NETWORK LAWYER was no factor. I VOW TO YOU forced the early pace outside and faded.
