CHANGE OF ORDERS broke sharp from the inside, gained a clear early margin, remained clear up the backstretch, responded when challenged by WINDING ROAD entering the second turn, dueled through the turn with that one, opened a clear margin and was clear late under steady urging. WINDING ROAD pressed the early pace from the outside, crept closer entering the second turn, challenged for the lead but could not match strides. MANKATO STRIKE stalked the early pace from the inside, advanced entering the second turn, responded along the rail but could only gain the show. HAZARDS OF LOVE forced the early pace from the outside but had nothing left for the drive. NORTH GOAL could only improve position. SINISTER was no factor. MIZZEN'S WAKE chased the early pace and tired. OH MIGHTY DOLLAR was never close. SMILE FOR UR I D was finished after a half.
