B L'S PAPA COO COO up close early from the outside, inched closer entering the second turn, responded when asked and wore down CAJUN TRIBUTE the final yards. CAJUN TRIBUTE close up from between foes, dueled up the backstretch, gained a clear margin entering the second turn, held a clear margin at the eighth pole but could not last. START YOUR GLITTER dueled from the outside for the early lead, remained engaged up the backstretch, held a forward position entering the drive but could not keep pace. K OTEE pressed the early pace from the inside but could only improve position. TRACK RECORD forced the early pace inside but was no threat late. WILLOUGHBY was no factor. I NV SLEW was no threat. MUST ACQUIT had little interest. SILVER WIND was never close. VEGAS STORM forced the early pace outside and gave way.
