Non winners of \$60,000 since August 2 allowed 3 lbs; non winners of two races other than maiden, claiming or starter since November 2 allowed 5 lbs; non winners of a race other than maiden, claiming, or starter since November 2 allowed 7 lbs. Preference to horses with the highest earnings in 2012-2013 (at time of entry). Different owners will have equal draw according to preferences. SU CASA G CASA up close early from the outside, dueled through the turn, remained engaged through the drive with TOP CAT BOOGIE and outfinished that one after a stretch long drive. TOP CAT BOOGIE dueled from between foes early, remained engaged through the turn, battled with the winner through the drive but was outfinished. AMANECER DE ORO dueled from the inside early, battled through the turn, fought through the stretch but could not keep pace. UNITAS dueled from the outside early, remained forward through the turn but had no late response. CUPID'S HIT chased the early pace from the inside but was no threat late. PIRATE ISLAND could only pass tired ones. RED PRODUCTION dueled from between foes and tired. YONAGUSKA STORM was no threat. CHIEF JAY showed little. GO FUZZY was never close.
