ZIP MOTION stalked the early pace from the inside, crept closer entering the second turn, responded but could not reach the winner. FREDDIE ONE BITE pressed the early pace from the outside, inched closer entering the second turn but could only gain the show. MASCULINO forced the early pace but had nothing left for the drive. HULA PIE close up from the inside, had no late response. E VALENTINO could only pass tired ones. COPPERVALE was no factor. BEANWAH'SMACHINE was no threat. C. C. DUBAI was never close. GAR forced the early pace and tired.
