LAWYER TIFFANY stalked the early pace from the outside, advanced entering the second turn, responded when asked but just missed. RILEYS MONARCH unhurried early from the inside, advanced entering the second turn, responded but could only gain the show. U BELONG TO ME pressed the early pace from the outside, made a bid entering the second turn but faltered late. TOUGH ISSIE could only improve position. HARLIE'S DREAMS chased the early pace from the inside, made a bid entering the second turn but flattened out. SCARLET TRIBUTE was no factor. CAT'S PRODUCTION chased the early pace and tired. PRODUCTION'S IDOL was no threat. LEE CITY forced the early pace outside and gave way.
