### Footnotes

AIDEN'S AFFAIR stalked the early pace from the inside, inched closer entering the second turn, altered outside for the drive and wore down front running MANDY'S DREAM the final furlong. MANDY'S DREAM broke clean from the outside to gain the early margin, remained clear up the backstretch, held a clear advantage at the eighth pole but could not last. BURNINGRICH well placed from the inside early, dropped back slightly up the backstretch, responded to pressure entering the drive, lacked room mid stretch, altered outside and was gaining late in a game effort. FLASHY FOOTNOTE outrun early, advanced outside up the backstretch, responded entering the drive and had a mild late gain. TUTT pressed the early pace outside but had nothing left. DOC OF THE BAY could only improve position. DREAMSALIVE was no factor. RENATA chased the early pace inside and tired. PUCKAPPEAL forced the early pace outside and tired. ROCK 'TIL DAWN up close early from the outside, gave way in the drive.
