BIENHEUREUX stalked the early pace from the inside, advanced entering the second turn, altered outside but could not reach the winner. LUCY E. outrun early, advanced inside entering the second turn, made a bid along the rail and was gaining late. MIRROR BAY forced the early pace outside but could not keep pace. SWEET EUGEENA dueled from the outside and tired. ISLAND BLUFF was no factor. MEMORIES OF WHO forced the early pace and tired.
