### Footnotes

PRADO'S MAIN MAN unhurried early from the inside, advanced entering the second turn, altered outside for the drive, dueled through the drive and was just up late. SA HOSS outrun early, advanced inside entering the second turn, altered outside entering the drive, brushed with CONAN entering the drive, responded to duel through the drive but was outfinished. CHERIE'S CASCADE pressed the early pace from the inside, dropped back entering the drive, responded along the rail to come again. BLUE TRIBUTE dueled from the inside early, battled up the backstretch, remained engaged through the drive but tired late. MAJOR CASE well placed from the outside, crept closer entering the second turn, was brushed when CONAN was forced over and had nothing left. CONAN forced the early pace from the inside, held a forward position entering the drive, was brushed and forced over the tired late. KEEP ON SMOKIN dueled from the outside and gave way.
