RUNNING RAIDER outrun early, advanced outside up the backstretch, reached a striking position entering the second turn, responded when asked and was along in time. WHISTLING DECISION forced the early pace from the outside, made a bid entering the second turn but could not match strides. REBECCA'S BAY well placed from the inside, inched closer entering the second turn, gained a clear margin at the eighth pole but could not last. MOO JEANEE MOO off a step slow, was unhurried early, advanced outside entering the second turn but had nothing left. CONSOLIDATOR BOY pressed the early pace inside but had no late response. GOOD KITTY was no factor. MY HOT SHOT chased the early pace from the inside, gained a clear margin entering the second turn, blew the turn entering the drive and was no threat late. WIRE ME SHERRY showed little. DAVORS JEWEL broke sharp from the inside, gained a clear early margin, dueled through the second turn then gave way.
