PRACTICE SQUAD dueled from the outside early, battled up the backstretch, remained engaged through the second turn, fought through the stretch with PIZZINI and inched clear of that one late. PIZZINI dueled from the inside early, battled up the backstretch, fought through the drive with the winner but could not match strides. HONEY DEW stalked the early pace from the inside, steadily advanced entering the second turn, responded and was gaining late. FEMME LA FITTE forced the early pace from the outside but had nothing left. HUFFS DIVY could only improve position. PRECIOUS MITTENS chased the early pace from the inside and tired. ERL'S SPIRIT forced the early pace and tired. IT'S ROXY was no factor. THAT SILVER was no threat. QUEEN OF CLASS chased the early pace and gave way.
