LADY TAMER settled behind the front runners early, began to advance position in the stretch and was up in time for place. DIXIELAND BULL raced three wide in the turn and was gaining ground in the late drive. GIBBYGIRL dueled for the early lead with RUSTON KITTY and had nothing left in the drive. BIG SWEETS chased the early pace and weakened in the stretch. EL REBECCA saved ground early and failed to rally late. RUSTON KITTY dueled early and gave way. SNAKE HIPS raced wide, saddle slipped and was eased to wire.
