PART OF MY FAMILY was allowed to settled then rallied three wide heading into the far turn, was in a strong drive and gained command in upper stretch and drew off in the end. BAD JOHN was allowed to settled then saved ground on the far turn and rallied along the inside in the stretch to be up for the place in the end. ESSENCE OF SPEED dueled for the lead from the inside, was in a long drive then drew off on the far turn but weakened in the stretch drive. REW'S BLUES was allowed to settled in the early going while inside, made a bid on the far turn and moved out to be three wide in upper stretch but came up empty in late stretch. SIERRA MAESTRA was unhurried early then rallied four wide on the far turn but failed to menace in the stretch. AUSTIN'S BUDDY was unhurried early then made a mild rally while two wide on the far turn, made a bid in the stretch but was in tight between rivals in late stretch. EVACUATION was unhurried early then was no threat. JUSTINIAN dueled for the lead while two wide, was used up and gave way. FLYING IDE through early and stopped. SUNDAY PREMIERE chased the pace while inside then stopped then entering the far turn.
