WICKED VOW was allowed to settled in the early going, started a run three wide on the backstretch then rallied heading into the far turn to take command, drew off in upper stretch then was kept to a drive in late stretch. SIR MAXWELL was unhurried early then rallied four wide on the far turn making a strong bid to mid stretch then came up empty in the end. BRENDYN JO was unhurried early then rallied five wide on the far turn making a bid to mid stretch but flattened out in the drive. REDSUGAR vied for the lead while between rivals, was in a long drive then weakened in the stretch drive. CHERIE'S CASCADE was unhurried early then raced three wide on the far turn making a bid to upper stretch then came up empty in the drive. MANDIMAX was settled the rallied six wide coming out of the far turn but failed to menace. AND MUSIC CAME was settled in the early going, made a two wide bid on the far turn then was inside in the stretch drive but was no menace in the stretch. SILVER PATRIOT was unhurried early then moved out to be five wide in the stretch and was no threat. SLIGO JOE vied for the lead while three wide on the first turn and backstretch, was in a long drive then gave way in the stretch drive. SIDE'S SONG vied for the early lead from the inside, was squeezed on the run down the backstretch and taken back then faltered in the stretch.
