Footnotes

SLIGHTLY USED stalked the early front runners, began to advance position heading into the turn, raced three wide and took command at the top of the stretch and held clear. PRIVATE PERSON vied for the early lead with TOLEDO TOWN, took the lead by a slight margin, matched strides in the upper stretch with SLIGHTLY USED and could not keep up the pace in the late drive. LAKE POMEROY was unhurried early and raced behind the front runners, raced two wide in the turn, and rallied to be up for show. PENNEY N A PRAYER raced up close chasing the early leaders, drifted in the stretch causing DIXIELAND REBEL to check sharply and came up empty late. DIXIELAND REBEL raced up close early behind the front runners, continued bid near the inside heading into the turn, was forced to check mid stretch and had nothing left late. OMEGA ME AMIGO raced evenly in the middle of the pack, raced three wide in the turn and was no threat late. TOLEDO TOWN showed speed in the early going and faded after a half. CAPTAIN AUSTIN failed to respond throughout. RAIL RUNNER raced near the inside and was no factor. BRIGEM D showed little throughout. After viewing replays stewards disqualified #9 PENNY N A PRAYER from fourth and placed fifth for interference in the stretch
