CHOCTAW LADY lacked early speed, raced three wide around the turn, made an outside bid and got up at the wire. FUTURE JUSTICE raced on the front end, led until late, got caught at the wire. FLASHY ISLAND GIRL vied for the early lead, forwardly placed throughout and got outfinished by the top two. BOMB THREAT void of early speed, moved up, but was no factor. RED HOT TEQUILA pressed the early pace, saved ground around the turn and weakened. CORPORAL GREINER raced within contention, then faded.
