PANTHER WARRIOR mild bid, bothered mid stretch, evenly to wire. QUICK GAME mild bid, evenly. SHINING SIXES late try. GASANGO broke out start, no factor. FLASHES MAGICAL WISH showed little, drifted out. PATSYS STREAKN AGAIN raced erratic. A STEWARDS INQUIRY WAS CALLED AGAINST #6 STRIKE COMMANDER FOR INTERFERENCE IN MID STRETCH. AFTER VIEWING REPLAYS STEWARDS DISQUALIFIED HIM FROM THIRD AND PLACED HIM FOURTH.
