STREAKIN GROSOREILLE bumped start, good try. RARE SHAKEM evenly, drifted in. BJS VITAL SIGNATURE hopped at start, drifted out, late try. ROSIE CORONA broke well, bobbled early, raced erratic. PRIZE SHAKER broke in air, drifted inward, no factor. KJR SPECIAL DASH forced out at start, no bid. THE TRAINER OF #5 STREAKIN GROSOREILLE LODGED A CLAIM OF FOUL AGAINST #4 A ROYAL FALCON FOR INTERFERENCE AT THE START OF THE RACE. AFTER VIEWING REPLAYS STEWARDS DISQUALIFIED #4 FROM SECOND AND PLACED HER FOURTH.
