JESS TAMBIE speed, drifted out late, best. PERFECT MOUNTAIN TEE rallied, held 2nd. ZEVIS RED WARRIOR drifted in sharply, bothered foes, dq. HAD TO BE A MAN solid even effort. EMBRUJO DINERO evenly, bothered stretch. JRD EASY DASHIN evenly, in tight, bothered stretch. TURBULENCE AHEAD no real threat, drifted out late. WILDCAT BILL broke out start, no factor. LA JOLLAS MAGIC early try, bothered stretch, gave way. JAB COOL LADY bumped start, no bid. THE JOCKEY OF #5 LA JOLLAS MAGIC LODGED A CLAIM OF FOUL AGAINST #10 ZEVIS RED WARRIOR FOR INTERFERENCE IN MID STRETCH. AFTER VIEWING REPLAYS, STEWARDS DISQUALIFIED #10 FROM THIRD AND PLACED HIM NINTH.
