MISS DELTA BLUES broke in start, bothered stretch, no bid. AFTER VIEWING REPLAYS, STEWARDS DISQUALIFIED #5 BIGTIME STREAKER FROM FIRST AND PLACED HER LAST FOR INTERFERENCE IN MID STRETCH.
