ZARKING chased the early pace while racing two wide into the far turn, was in a long drive and powered to the front in mid stretch and drew off in the end. IMPECCABLE RULER set the early pace while inside, was in a long drive then was collared in upper stretch, dug in throughout upper stretch then weakened and held the place safe in the end. TOO MUCH SAUCE was two wide on the run down the backstretch and made a three wide middle move into the far turn but raced evenly in the stretch. TONY BOY was inside on the backstretch, raced evenly and failed to menace. STORM N PUNCH was unhurried early then was no menace. ATRO was allowed to settled then failed to menace. LEAH'S WARRIOR was allowed to settled then was no factor. JULIAS WILD SIDE was unhurried early then was no threat. FINN SWITCH was outrun. SHERYAR COUNTY showed brief speed then stopped.
