MADAME CACTUS allowed the pace to go early, asked for some run toward the inside midway on the final turn, steered out to be four wide for the drive, finished with good late energy to be clear at the wire. SITTING AT THE BAR off the pace, five down to four wide through the first turn, advanced while continuing four wide in the second turn, took over into the lane, proved no match for the winner late. CAYLLANO within striking distance after breaking in good order, moved up inside to challenge late backstretch, vied into and through upper stretch inside the runner up, weakened in the late going. PROMISE ME MORE lacked early speed off the inside, roused for the drive, displayed some late interest while remaining off the inside. ILE ST. MOLLY bobbled at the start, quickly recovered to move up to press the issue, vied through the second turn well off the inside, weakened in the late going. EDOLIE raced off the pace while outside, carried out six wide turning for home, made little impact in the drive. LONNIE BELL fell back to trail after the start, continued back, passed some faltering foes while never a threat. MISS GOODTHING within striking distance for a half, gave way. I DARE U EM off the pace, swung out five wide exiting the final turn, no late kick. MY DAUGHTER'S SONG got clear soon after the start despite bobbling slightly, set the pace off the inside, stopped when headed second turn.
