MR. PORTER well back for five furlongs, swept to the front in the second turn on the outside, gained the advantage but was outfinished in the late going. DANCE CALLER got clear after the start, again onto the backstretch, offered little resistance to the top two when they came alongside midway on the second turn, held the show. FAST TIME STREAKER moved up to force the issue three wide past the wire the first time, chased the leader up the backstretch, had little left for the drive. KITTY BLONDE settled off the pace and the inside, lacked a rally. POW POW pressured the leader early from between foes, steadily faded.
