STEAM THAT KETTLE vied for the early lead, being challenged by SHE STORMS, took the advantage around the turn and drove clear down the stretch. SHE STORMS dueled for the early lead, proved no match late for the winner, but was a clear second. ERL GIRL raced within striking distance, made a late bid, but was no match for the top two. DELITEFUL AFFAIR raced in the back of the pack in the early part, showed late interest, but was no factor. WORLDLY BROAD showed early speed and faded. HAYLIE'S PASSAGE raced evenly near the back and was no threat. JENNA'S NO ANGEL pressed the early pace and retreated. LADY MOJO void of early speed and showed little.
