DREAM CHASER was allowed to settle then rallied on the turn while three wide, stayed three wide for the stretch drive and was up in the final strides. DEPUTY DEHERE was inside then angled out three wide entering the turn, moved out to be four wide in upper stretch and was gaining ground in late stretch but was too late in the end. UNCLE BOBBY set the pace then drew off on the turn, was hard used then weakened in late stretch. KNOCKYA LIGHTS OUT was inside and saving ground on the turn, rallied along the inside in the stretch to be gaining ground but was not good enough. RUSHMORE was allowed to settle and raced three wide on the turn, was gaining ground but was no menace in late stretch. ARCHUCK was five wide on the turn then was no threat in the stretch. GUILTY PLEA stumbled at the start then was hustled along to be in contention then failed to menace in the stretch drive. TOLEDO TOWN chased the pace while two wide, was used up then faltered in late stretch. KISSERL IS MY NAME was in tight heading into the turn, was taken up off heels then lacked a rally in the stretch drive. MACHO TIME chased the early pace then stopped and was being eased up in deep stretch.
